In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).</li><li>2. The Vendor reserves the right to close the ICC Venue at any time if all the specified residential properties have been sold out.</li><li>3. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 9:00 p.m. on any date of sale, for the safety of the prospective purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to the ICC Venue.
